(THIS AGREEMENT ALSO INCLUDES FREE DESIGNS FROM WWW.SEWSEWPRINCESS.COM AND FREE DESIGNS FROM SEW SEW PRINCESS YAHOO GROUP.) BY PURCHASING THE DESIGN(S) YOU ACKNOWLEDGE THAT YOU HAVE READ AND UNDERSTAND THE FOLLOWING TERMS AND AGREE TO BE BOUND BY THEM. 1. The Design files are licensed, not sold, to you. You have a nonexclusive, nontransferable, limited license to use the Design files. THIS LICENSE IS LIMITED TO YOUR OWN PERSONAL USE. You agree that you will not distribute or otherwise provide the design files to any third party. You further agree to keep confidential and use your best efforts to prevent and protect the Design files from unauthorized disclosures or use. Sew Sew Princess reserves all rights, title and interest to the Design files not expressly granted to you under this agreement.
2. You are not permitted to sell, rent, lease, lend or otherwise transfer the Design files on a permanent or temporary basis without the consent of Sew Sew Princess. It is a violation of copyright law to sell, trade, copy, transfer, share with friends or send by e-mail copies of this design.
3. The design may be stitched on shirts, totes, hats and other wearable garments or accessories and other finished items. Design may be stitched onto items for personal use or as gifts. Designs may not be modified. This design is not intended for mass production. Distribution is limited to 25 items. If you intend to produce more embroidered items please contact Sew Sew Princess, by letter, email, or phone, with your request. You may display the finished item on a website, but the credit must be given to sewsewprincess with a link back to www.sewsewprincess.com.
4. To the maximum extent provided under applicable law, the Design files are provided "AS IS" without warranty of any kind. In no event will Sew Sew Princess be liable to you or any third party for any incidental, indirect, special, or consequential or punitive damages for lost data or lost profits, arising from or relating to this agreement, regardless of the nature of the claim.
